AGENDA

1) Call to Order

The meeting was called to order at 1:10 pm EST. President Carolyn Monaco was in the Chair.

Carolyn expressed a warm welcome to the individuals who registered for this second National AGM conducted via Zoom. A minimum of 25 voting members are required, either in person or represented by proxy, in order for this meeting to be an official AGM. Total attendance was 12 voting members present, and 13 voting members represented by proxy.

Regarding the logistics of actual voting on Zoom, Carolyn explained the option of raising one's hand.

2) Approval of the Agenda

Motion 2021 AGM – 01: Motion to approve the agenda:

It was moved by Linda Mamer, seconded by Wanda Schellenberg that the agenda for the 46th National AGM be approved.

3) Approval of the Minutes of 2020 AGM via Zoom

Tom McFadden briefly provided an overview of the minutes from the 2020 National AGM that was conducted via zoom.

4) Report of the President, CDBA National

Using a PowerPoint presentation, Carolyn Monaco spoke to the challenges of the past year during the COVID-19 pandemic, noting how well CDBA chapters performed. Accountant Peter Shennett will be presenting his audited financial report for the past fiscal year April 1, 2020 through March 31, 2021.

George Brown College's 2021 Intervenor Program student graduation was conducted virtually via zoom. National awards – Andrew Love Memorial and Excellence in Field Placement – were presented to deserving student graduates from both 2020 and 2021. GBC recently announced that its 2-year Intervenor Diploma program will be replaced in May 2022 by a 1-year online certificate program. You can refer to the summer issue of Intervention magazine, or contact GBC directly, for more information.

Last spring, 2 young female students from Chatham, Ontario raised over \$700 for CDBA National by way of a school project selling chocolate. This was a remarkable and generous gesture which CDBA profiled in the summer issue Intervention magazine. Our annual "Lend-A-Hand" golf tournament fundraiser resumed this year after being cancelled last year. Net profit was nearly \$11,000.

Regarding Deafblind International, face-to-face management meetings were cancelled this past year, but hopefully the Dbl International Conference in Ottawa will be a go in July 2023. The Dbl Review magazine went entirely digital, while individual membership was offered at no charge.

The Dbl Network of the Americas conference in March 2021, in partnership with the Texas School for the Blind, was held virtually.

National Deafblind Awareness Month was celebrated in June utilizing a yarn bombing initiative initiated by Dbl.

To conclude, Carolyn thanked retiring National Board member Renee Landry for her significant contribution to National since September 2017.

5) Report of the Executive Director, CDBA National

Tom McFadden presented his report on the activities of CDBA National over the past year, hoping to avoid overlap with Carolyn's Report of the President.

After being cancelled in 2020 due to COVID-19, our "Lend-A-Hand" golf tournament fundraiser helped us raise much needed funds, 10% of which go directly into the National Support Fund. Tom expressed his appreciation to title sponsor Cooperators Insurance, the hole, golf cart and meal sponsors, and the 76 golfers and 5 volunteers for making this event a real success.

For the 7th consecutive year, Deafblind Awareness Month throughout Canada was celebrated in June with a "yarn bombing" theme crafted by Deafblind International (DbI). The pandemic once again forced the cancellation of the traditional Senate of Canada reception in Ottawa.

Tom acknowledged the continued funding support of the federal Office of Disability Issues through the Social Development Partnership program – Disability component (SDPP-D). The original 3-year operational grant of \$45,000 annually was extended another year through to April of 2023. This will provide National with a degree of certainty in terms of its overall planning in the foreseeable future.

Despite significant pandemic restrictions, a resulting reduction in expenditures helped to benefit National with a substantial surplus for the fiscal year.

Communications with members and their families, corporate partners and interested supporters continued with the publication of 2 issues of "Intervention" magazine, quarterly e-newsletters and regular e-blasts on topics of interest.

Tom expressed his gratitude for the continued partnership with our CDBA provincial chapters in BC, SK and NB, and acknowledged the outstanding contributions of Paul Nobes (CDBA Webmaster & IT Officer); Cynthia Skilling (Graphic Designer) and Christiane Roswell (Bookkeeper) throughout the year.

**REPORT OF THE NATIONAL EXECUTIVE DIRECTOR
to the 47th
CDBA NATIONAL ANNUAL GENERAL MEETING
Saturday, September 24, 2022**

Way back in 2011, during my first AGM as national executive director, I recall speaking about a **long-term vision** for building a bright and prosperous future for this national charitable organization. This vision was defined as an opportunity to look at things that were realistically achievable, and would serve as a guiding and reinforcing statement of intent, of focus and of ongoing commitment to help better the lives of those persons who are deafblind and their families.

Later that same year in Fredericton, the National Board discussed and confirmed a **Strategic Plan** which focused on the need:

- for increased visibility;
- for improved communication, internally and externally;
- for better collaboration with stakeholders and like-minded organization in the NFP sector;
- for cost-effective administration and management of both volunteer and financial resources; and
- for new and innovative services to members who are deafblind and their families.

How have we done? It is anticipated that the newly-elected National Board of Directors will embark on a **new Strategic Plan** encompassing the next 5 years, from 2023-2028. This will for sure be the time to reflect on what we have accomplished; on the opportunities we may have missed; and on the immense challenges ahead.

The welcomed return of our annual “**Lend-a-Hand**” **charity golf tournament**, after being cancelled in 2020, proved to be quite a success. Our primary fundraiser was sponsored again by insurance giant Cooperators and raised much needed funds, despite COVID-related protocols. Ten percent (10%) of net proceeds are put into our National Support Fund which provides emergency funds, upon application, for CDBA members who are deafblind and their families.

For the 8th consecutive year, “**Deafblind Awareness Month**” was celebrated during the month of June with a “yarn bombing” theme crafted by Deafblind International (DbI). This global phenomenon saw over 20 countries come together to yarn bomb for deafblind awareness. Activities in Canada were coordinated by a working committee of representatives from a number of not-for-profits in the field of deafblindness, including CDBA. Unfortunately, the traditional Senate of Canada Reception in Ottawa was reduced to a “meet & greet” scenario due to the lasting effects of the COVID-19 pandemic.

While the past year was difficult in many ways, pandemic restrictions have actually benefited the Association financially. I will leave it to our accountant Peter Shennett to expand on this during his **Audited Financial Report**.

As I reported last year at this time, CDBA National had to manage its operations under a cloud of uncertainty, not ever really sure of the level of **government funding** it could count on. However, in April 2019, the Office of Disability Issues, through the Social Development Partnership Program-Disability (SDPP-D) program, made our annual “sustaining” grant more “operational”, moving away from an emphasis on “project and outcomes-based funding, and in the process, approving \$45,000 annually for three years through April 2022. This funding agreement has since been extended another year, through April 2023!

It must be noted that a **Federal grant application**, which was submitted for the same amount of \$45,000 annually over 3 years starting on April 1, 2023, has not yet been approved.

In August of 2020, the federal government approved our application for an additional \$11,244 **to enhance our communications and engagement activities during, and affected by, the pandemic**. To date this money has not been completely spent. Some of the \$7,600 surplus will be used to cover the cost of our 8-10 minute you-tube awareness video. Since awareness of deafblindness is so much an integral part of what we do, this video, which will be slated for posting on our website, should turn out to be a very useful tool.

Additionally, **National is currently updating and re-designing its website**. A portion of these surplus funds will also be used to cover costs related to this project.

Your Association continued to communicate with members, their families, partner agencies and interested parties via our **bi-annual "Intervention" news magazine; a quarterly e-newsletter** with deafblind news from Canada and around the globe; and **regular e-blasts** about issues and newsworthy announcements of interest to CDBA.

When **CDBA Alberta** ceased its formal operations a couple of years ago, due in large part to volunteer exhaustion and lack of staff, AB Chapter funds were transferred to CDBA National to be managed. Recent internal discussions about how to utilize this money has resulted in the creation of a **Memorial Scholarship in the name of Wayne Turnbull**, a deafblind consumer, volunteer and advocate from the province of Alberta.

To conclude, although the current financial position of the Association is encouraging, there are **3 key issues to be addressed going forward**.

The first is to find a new corporate Title Sponsor for our annual golf

tournament fundraiser. The Cooperators after 3 years is moving on due to a significant change in circumstances.

The second is Board succession planning, which is directly related to our National Bylaws which restrict the number of Directors-at-Large to the same number of Chapter Reps, currently 3 & 3. It may be time for this 1 to 1 ratio to be increased to 2 to 1, if for no other reason but to impact workload on Board members who are also asked to serve on one or more standing committees in addition to their 9-10 monthly Board meetings during the fiscal year.

The third issue involves member recruitment and retention. The number of members in good standing with voting privileges at the 2021 AGM fell to 141, down from 2020 when the number was 158. This year, the number has dropped once again to 123. In comparison, at the end of August 2015, we had 277 members paid and in good standing. This decline will merit future discussion by the National Board about potential solutions. The impact of COVID-19 on Chapter summer programs certainly has been a factor, especially in Ontario when CDBA Ontario decided to break rank with CDBA National and re-brand itself. It is a fact that since 2011, we have lost Chapters in Manitoba, Ontario and Alberta.

Good news is 2-year membership renewals have remained relatively constant year over year, suggesting a significant core of recurring members. CDBA has essentially an aging membership base that perhaps has not been engaged or activated fully as advocates and sources of knowledge. I take some responsibility for this. There are in my view lost opportunities when we don't fully benefit from the many "lived" experiences our member families have to share. We need to solicit more participation.

Our membership breakdown compared with the past 2 years looks like this:

CDBA-New Brunswick Chapter 2021-2022 Annual Report *Kevin Symes, Executive Director Chapter*

Mission and Mandate: Since 1982, the Canadian Deafblind Association-NB Inc. (CDBA-NB) has been involved in providing support and services through Intervention to individuals who are deafblind, deaf, or blind with associated disabilities and their families throughout New Brunswick and Prince Edward Island. CDBA-NB Inc. helps people of all ages and with a wide range of complex difficulties. As client's needs have changed, CDBA-NB Inc. has adapted to meet those needs, offering quality services that place the individual, and their family, at the heart of all that we do. CDBA-NB Inc. is committed to assisting all persons to achieve, with Intervention, the best quality of life.

Board of Directors CDBA-NB has a wonderful group of Board members who believe in the services and the people we work with. We are currently seeking new Board members; if you or someone you know would be interested in becoming involved, please let us know.

Intervention Services: NB/PEI Intervention Services are provided through the Department of Social Development. Hours of Intervention vary depending on the client's needs. CDBA-NB is currently servicing 22 clients with 24 Intervenors.

Independent Living: There have been many challenges, however, CDBA-NB believes that this is well worth all the effort and is still wishes to move this project forward.

Awareness: This year has been a challenge, because of all the Covid 19 restrictions. However, CDBA-NB took part in a global "Yarn Bombing" initiative. CDBA-NB wrapped a tree in front of the New Brunswick Legislative Build, for Deafblind Awareness Month. Intervenors and Clients also to part in activities in other parts of New Brunswick.

Work Placement Experiences and Training for Clients We have several clients who work in a variety of different job placements with their Intervenor, such as: Value Village (Saint John), Superstore (Fredericton), Sobeys (Bathurst), CDBA-NB office (Fredericton) & SPCA (Bathurst) CDBA-NB clients also volunteer at the library, food bank, Boutique Encore, SpinCo Fredericton & the Veterans Center.

Newsletter The staff continues to produce two newsletters a year - June and December. Intervenors, please send us pictures and stories about your client so that we can share them with the other members of CDBA-NB.19

CDBA-NB Office Staffing

Sheena continues to work as the Administrative Support role with supports from her Intervenor. Carol Kennard is our Office Manager; Chantel Whitman is the Manager of Intervention Services and Kevin Symes is the Executive Director. If you have any concerns or questions, please let us know.

Staff Training:

Intervenors usually have a Home Care or the Human Services Counsellor course plus Level 5 sign language and Level I Braille, if required by the client. Along with this training, Intervenors are strongly urged to attend CDBA sponsored workshops each year. CDBA-NB pays for CPR and CPR upgrading. Other workshops would include behaviour management, recreation activities, orientation and mobility, crisis intervention, swimming, fundraising techniques, working with families and/or group home staff, sign language, braille, and deafblind technology.

Other Support Staff:

Any supporting professional that the client requires is provided either by the Department of Education or Social Development. The Intervenor is expected to learn and follow through with certain programs, i.e. Orientation and mobility, occupational/physiotherapy. The Intervenor will often accompany the client/parent to medical and dental appointments. All support persons become part of the client's team.

Conferences/Professional Development:

All Intervenors, clients, family members and staff are eligible to apply to attend workshops or a conference of interest, to the NB Board of Directors (following the established guidelines).

Funding Requests

Submissions were made to several different groups for support. The names of the organizations that support CDBA-NB can be found in the Fundraising Report.

Summer Camp:

We hope to be able to move forward with a CDBA-NB Camp in the summer of 2023. It has been a while since we have all been together. The families and Intervenors should receive more information in Spring of 2023.

Other activities:

To offset the loss of this year's camp, we are doing various day trips taking into consideration the Covid 19 health guidelines. This year the Intervenors and clients decided what they would like to do. So, examples are day trips to the Moncton Zoo, day trip to Fredericton Clay Café, movie and a meal and some simply went out for a meal. CDBA-NB helps support our clients in several different ways. movie passes, bowling, sensory garden, swimming, gym/exercise, golf, and "clubhouse" to name a few.

Lorna Thompson Memorial Snoezelen Room

The Snoezelen room is now open to outside groups. We have been cleaning the room after each use as per Department of Health guidelines.

Teaching Kitchen:

The teaching kitchen is now open for use. We hope, to soon, have Intervenors and clients back in the kitchen and cooking.

NBDEN

CDBA-NB is a member of NBDEN. As a result of our work with NBDEN we have had an increased policy engagement, there are significant policy changes that have had extremely positive impacts on persons with a disability in New Brunswick. For more information about NBDEN and what we do, please contact the CDBA-NB Executive Director.

CDBA-NB Activities

This year, CDBA-NB has been a part of several outside committees. Some of these activities are as follows: ADAPT Standards Review Committee, ReThink Ability Steering Committee, National Deafblind Awareness Committee, DBI Ottawa 2023 Sponsorship Committee and CDBA-National Board of Directors conference calls.

2021/2022 Year in review:

Leanne stepped into the Executive Director Role at CDBA-SK on a temporary basis at the end of December 2021, and by the beginning of February, the position became permanent. When Dana resigned, there was a bit of a shuffle within the management team with one of the Supervisors moving into the Program Admin Assistant role and the hiring of a new Supervisor at the Kerr home.

We are currently serving 10 Individuals (1 of which is a child under Child and Family Programs). Arrianna H. finally moved in to the Kerr house in September 2021 after a very lengthy admission process.

CDBA continues to work with the VADIS group and the Reference Team within CDBA. The Reference Team works together with the staff to help build a healthier workplace culture. We recorded some "Tea Time" sessions for those who could not attend while they were happening. While this was helpful when we were not meeting as a larger group, we have now moved this format to the monthly staff meetings. Increasing communication and building a healthy workplace is very important to CDBA and we plan to continue working on this.

Highlights this year were:

- Lots more family contact over this past year and the start-up of in-home family visits
- The CNIB invited us to a picnic in Prince Albert as well as their deafblind community awareness event at Lawson Civic Centre
- Staff appreciation in March with notepads and pens (with a personalized note for each staff)
- Disability Service Professional week, acknowledged with tasty treats for our Intervenors

- Saskatchewan declared June as deafblind awareness month, matching that of other provinces.
- The Summer Student grant was awarded again for this summer.

Training is getting back on track now that we are able to hold more in-person training sessions. There have also been a huge number of new Intervenors hired in the last few months, so everyone is working very hard at orientating them with everything they need to know to support the Individuals and be successful at CDBA.

The annual golf tournament with the support of MacDermid Lamarsh was held on June 1. This was held at The Legends Golf Club in Warman and the reception was at the Brian King Centre with Touch of Ukraine providing supper. Despite the exceptionally windy day, so many people were saying this was the most fun they have had at our golf tournament. MacDermid Lamarsh and our own board of directors were instrumental in the success of this tournament. We ended up raising a total of \$22,656.95 this year!

CDBA-SK has partnered with several agencies in Saskatchewan in order to offer a Truth and Reconciliation speaker series for team members throughout the disability sector. Dr. Jarvis Swidrovich is an incredible speaker and we were so fortunate to be able to release that on National Indigenous Peoples Day. The second speaker, Raven Sinclair, will be released on September 30, The National Day for Truth and Reconciliation. Both of these speakers have remarkable stories to tell which helps everyone gain a bit of understanding of their past history and why it is important to acknowledge the truth.

Although this past year has been filled with significant change and new challenges, we never deviate from our goal of providing quality care for people with deafblindness.

- 9 outreach families: 23 local families
- 209 virtual visits; 120 hours of virtual outreach support
- 19 in-home visits during gradual re-entry to in-person visits
- 11 children attended preschool/daycare
- 11 children transitioned to Kindergarten September 2021
- Deafblind education, training sessions and joint visits were provided to preschools and daycares primarily virtually throughout BC, as well as to the professional teams and families of the children.
- Parent sharing workshop sessions were held virtually throughout the year.

• **Intervention Program:**

- Summer IP 2021 (9 weeks)
- 48 participants
- 4 preschooler-age and 44 school-age
- 64 Intervenors employed
- Winter IP 2021-22
- 24 participants
- 2 preschooler-age and 22 school-age
- 27 Intervenors employed
- Spring IP 2022
- 33 participants
- 2 preschooler-age and 31 school-age
- 38 Intervenors employed

• **Virtual Recreation Program:**

- Continues to be a strong program and offers opportunity for networking, sharing and consultation.

- Planned and facilitated by our Intervenor Resource Team.
- We held 6 activities through the summer, 2 for the Fall, 2 for the Winter and 2 for the Spring.
- Children/youth with deafblindness, their Intervenors and families welcome, as well as CDBA-BC Members.
- Boxes of corresponding craft supplies were shipped to each child's home
- Activities include all sensory components and are designed to meet the needs of all participants. We also include many theme-related corresponding ASL signs, as well as fun songs and stories.

- **Youth Transition Program:**

- Training (Adult Services/Consult) and PATHS continued to be suspended due to the pandemic, but some are planned for the 2022-23 year.
- Supported 6 youth moving through the transition phase to adult services.
- Participated in many school team meetings for Kindergarten transitions and school IEPs.

- **Intervenor Training**

- New training program for our Intervenors.
- We have adopted (and are adapting) the Modules from the Open Hands, Open Access Modules from the Minnesota Deafblind Project.
- 11 students participated in 2 modules: *The Sensory System, The Brain and Learning*, and *'Intervenor Strategies'*.

- **Projects**

- Intervenor/or Community of Practice: Munch 'n' Learn' workshops – 2
